CONTEST RULES AND REGULATIONS

1. The entry fee to participate in the Cookin' on Kampska Burger Battle is \$20.00 per contestant.
2. The contest is open to individuals 18 years of age and older.
3. Maximum of two cooks allowed in the cooking area.
4. Each contestant will be assigned a cooking area with a table, small tabletop charcoal grill, charcoal, and lighting tools. We request that you keep all of your equipment within this area.
5. Each contestant will receive one pound of ground beef and a numbered turn-in container. You must bring all other desired seasonings, condiments, garnishes, buns (if you choose to use them), and cooking utensils. If you want to use another ground meat other than beef, you may bring your own. (Please bring hot pads or oven gloves as the lids to the grills may be hot.)
6. Contest begins promptly at 10:00 a.m.
7. The official turn in time will be 11:00 a.m. with a window of 10 minutes (5 minutes before time and 5 minutes after time). No late entries will be accepted.
8. Each contestant must turn in 3 whole burgers or 1 burger cut in 3 equal pieces in the provided numbered container.
9. The judging for this event will be blind to ensure the integrity of the event. Entries will be judged on appearance, taste, and creativity. All decisions and interpretations by the judges are final.
10. Awards will be presented to the 1st, 2nd, and 3rd place winners during the cook-off awards ceremony at 4:30 p.m. on Saturday, July 18th.
11. Each contestant is responsible for the clean-up of their assigned cooking area. Trash and hot ash disposal containers will be available.
12. NO alcohol is allowed in the preparation and cooking areas.
13. Failure to follow any of these rules will result in disqualification of the contestant.
